- Under the provisions in NB-263, RCI-1, *Rules for Commissioned Inspectors*, when a commission and/or endorsement has
 not been renewed for more than two (2) years, the commission and/or endorsement may be reinstated, provided the
 formerly Commissioned Inspector and the employer complete and submit the *Application for Reinstatement*, and the
 formerly Commissioned Inspector retakes and passes any required examination for the commission or endorsement.
 The applicant must complete Sections 1, 2, 4, and 5 of this form.
- Under the provisions in NB-263, RCI-1, *Rules for Commissioned Inspectors*, when a commission and/or endorsement has not been renewed for **less than two (2) years**, the commission and/or endorsement may be reinstated provided the formerly Commissioned Inspector and the employer complete and submit the *Application for Reinstatement*, and the formerly Commissioned Inspector has completed continuing education course(s) (see Paragraph 1-8 of RCI-1) for each commission and/or endorsement within twelve (12) months prior to the submittal date of the *Application of Reinstatement*. **The applicant must complete Sections 1, 2, 3, and 5 of this form**.

You can then open the application, type in your information, and print the application form. (Any application filled in while viewing it online will not be saved.) All applications must be typed and may be emailed, faxed, or mailed to the National Board.

- 3. Please enter the applicant's name as it appears on the applicant's passport/government-issued ID/driver's license.
